#### Introduction of the 2024 Operational & Supplemental Budget

This is the operational budget only. Brought down to 85K from 90K in previous years. The below notes refer to line items within the budget.

Volunteer checks are net zero.

Pizza budget is up to 15K.

Golf Tournament is the same.

Gold Cards- been a flat number since we worked a deal with adrenaline.

Concessions- remaining the same at 9k. Took a loss in 2023.

Sponsorship and SOTS was bumped up to 17K.

Youth camp net zero.

Kick Off- not doing any longer.

Coaches- 50K has been a flat number the last 5 years. The number will be dependent upon the school contract.

Freshman night net zero should we get a sponsor.

Game hydration and nutrition we pay for.

Uniforms are a set budget for every year.

Misc clothing is the coaches apparel. Bumpers up to 1500 due to inflation.

Equip and maintenance remained the same.

Team Building- net zero.

Acct remained the same.

Website remained the same. Scholarships were \$2500 to 1K going back to 2 scholarships from 5 and still offering 2 from Flag Football. It's like pulling teeth to get kids to apply.

Bussing, for coach buses for the players.

Coaches Clinic from \$1500 to \$3500 due to inflation.

Season Celebrations from \$500 for each class. Team banners another \$500 comes out from this.

Season End Awards- covers plaques, stayed the same.

Storage went up \$500. Store paint stripers, generators etc at this storage facility.

Video/Tech- Quickbooks, Coaches database, Social Media.

Capital Plan, need tv and a cart as well as upgrade the end zone system at some point.
